## **EFCC** arraigns former Gombe revenue board chair over N25.6m scam

The Economic and **Financial** Crimes Commission (EFCC) vesterday arraigned the former chairman of the Gombe State Board of Internal Revenue and three others over alleged N25.6m fraud.

The former chairman Atiku Mu'azu Bayum, chief store officer Mohammed

chief accountant Ibrahim Abubakar and a director Abubakar Usman were arraigned before a Federal High Court in Gombe on a 30-count charge bordering on forgery, and obtaining money by false pretence.

According to the court documents, the defendants were alleged to have used their positions to conspire, forge documents and obtain the sum of N25, 060, 000 belonging to the Gombe State Government.

court was told The that investigation by the Gombe zonal office of the EFCC revealed that the documents forged include several receipt attached to payment vouchers for which payments were released and converted to their personal used in the cause of their duties.

However, all the defendants pleaded not guilty to all the charge preferred against them. In view of their plea, the prosecution counsel Barrister Israel Akande applied for a date of trial.

The presiding judge, Justice Mohammed Garba Umar granted the defendants bail in the sum of N2m each and two sureties in like sum for each. He adjourned the case to October 11 for hearing.

# Man commits suicide as lightening kills student in Anambra

A 40-year-old man identified as Nnamdi Omezi committed suicide yesterday in Obosi, Idemili North Local Government Area of Anambra

He was said to have hung himself around 4pm from a ceiling fan in his apartment located on Fred Ezika Street, Odume layout.

His body was still dangling from where it was suspended when the police led by the DPO Isiowulu Division arrived at the scene.

A 100-level student of Anambra State University, Igbariam also died yesterday following a thunder lightening during a heavy downpour in the area.

Vincent Uche Mbanefo, a student of Agriculture Extension was said to be in his lodge at Achalla around 5pm when the incident happened.

Police Public Relations Officer Anambra State Police Command, Haruna Mohammed confirmed both

He said the police attached to Isiowulu Division visited the scene of the suicide incident with a medical doctor, who certified the victim dead.

He however said efforts to recover the corpse for autopsy proved abortive, as the community insisted on ritual rites to be conducted as a traditional requirement before moving the corpse.

Mohammed added that the body of the student had been taken to his Aguleri home for burial.

### Agency identifies victims of Niger flood Oyo govt promises to compensate victims of Bodija clashes

All but one victim of the Monday flood disaster in Rafin Gora community and Angwar Nasarawa in Kontagora local government area of Niger State were girls, Alhaji Ibrahim Inga, Director General of the State Management **Emergency** Agency, has disclosed.

Malam Inga, who shed light on the development to *Daily* Trust yesterday in Minna, said the Rafin Gora incident claimed seven lives, all girls, while one other, Malama Harisa Musa, is still missing as at the time of filing this report.

He said the two victims of the Angwar Nasarawa incident Maryam Salihu and Yahaya Salihu were of the same parent.

Among the victims of the Angwar Gora incident include Hanifa Mansur, Fauziya Danlumu, Nana Bello Dankayi, Hadiza Auwali, Na'ima Usman, Rashida Sahabi and Khadija Salah.

The Director General said information before the agency indicates that they were between the ages of 16

He said a boy survived by clinging on to a tree before rescue eventually came his

He said seven bodies were recovered from the Rafi Gora incident and have since been buried according to Islamic rites.

He said in the Angwar Nasarawa, Yahaya Salihu, 8, lost his slippers in the flood and his elder sister, Maryam, who was nearby, tried the recover the slippers but was washed away by the flood.

On noticing the condition of his sister, Yahaya made to go for her rescue and also lost his life.

He said the bodies of the two siblings have since been recovered and interred.

### **Uncle sets** toddler ablaze for defecating

The Police PRO in the state, Ms Irene Ugbo, confirmed the story, saying the father and the mother have been arrested and investigation on the matter was ongoing.
